

Adventure Park Regulations

1. ACCESS TO THE PARK IS PERMITTED ONLY TO THOSE WHO:

- a) know that they are in good physical shape, that they have no heart problems and that they have not ingested substances that can alter their behavior (alcohol, drugs, medicaments, etc.), are in good moral shape (to avoid panic) and not to be subject to dizziness.
- b) It is **MANDATORY** to follow the introductory course (briefing) which instructs you on the conditions of use of the routes and on the evolution technique. Respect the safety notions described there and especially double insurance.

Remain permanently anchored to at least one safety cable. On each game only 1 person can access at a time and on the platforms a maximum of 3 people at the same time. Use scrupulously the personal protective equipment that is delivered to you at the time of paying for the entrance ticket. Adopt a sports outfit in connection with this activity (especially wearing sports shoes). Tie your hair and remove all accessories that can get caught (scarves, hoods, earrings, etc.), avoid carrying valuables (glasses, chains, keys, etc.) and in general any object that could fall during the evolution among the trees.

2. GENERAL PROVISIONS:

- a) Do not hesitate to ask for advice, to tell us all your difficulties, or to ask for our intervention at any time.
- b) Pila company reserves the right to:
 - close the routes in case of bad weather conditions.
 - to exclude people who with their behavior put their own or others at risk, (example: not respecting the rules and safety instructions), or who do not respect our provisions: in this case no reimbursement can be required.
 - refuse access to the paths to people who we believe do not meet the necessary physical and moral requirements.
- c) The PILA Adventure Park assumes no responsibility in the event of an accident caused by your negligence and failure to comply with safety regulations, for the loss or breakage of personal belongings, or more generally for other reasons. You are the guarantor of your safety.

3. ACCESS TO THE ROUTES:

Taking into consideration the specificity of this activity:

- a) access to the routes is limited to opening hours: from 10.00 to 18.00
- b) access to the routes is reserved for customers in possession of a valid ticket of payment made. The access ticket entitles you to stay inside the Adventure Park for a maximum of 2 hours
- c) the briefing (introductory course) starts every 30 minutes from 10.00 to 16.00. Participation to the briefing is also mandatory for those who have already used our or another adventure park. It is advisable to arrive 10-15 minutes early to complete the procedures for accessing the Park (payment control, distribution of equipment and dressing). In the event of any delays, access to the adventure park will be recovered in subsequent time slots after checking the availability of entrances.
- d) Access to the adventure park is allowed to:
 - super baby of at least 5 years and required height: from 130 cm.* to 150 cm.*
 - children of at least 6 years and required height: from 140 cm. * to 160 cm. *
 - children up to 15 years and minimum required height: 160 cm. *
 - adults aged 15 and over.

* the height measurement must be taken from the ground up to the wrist with the arm stretched upwards.
- e) access to the FUCHSIA course is authorized for children measuring more than 1.30 m (height at the wrist and with the arm stretched upwards) who must be supervised by a responsible adult.
- f) access to the YELLOW path is authorized for children who measure more than 1.40 m (height at the wrist and with arm stretched upwards) who must be supervised by a responsible adult.
- g) access to the GREEN, BLUE RED routes is authorized for all people who measure more than 1.60 m (height at the wrist with arm stretched upwards). The supervision of 1 adult every 6 minors is mandatory.
- h) it is believed that the participation of minors has been granted by the parents, whether they accompany or supervise minors on the routes.
- i) groups and schools proceed under the responsibility of their organizer.
- j) all people present on the routes must visibly wear the bracelet certifying their right of entry.
- k) it is strongly not recommended to stop or walk under the games or platforms.
- l) it is strictly forbidden to leave the park area with safety equipment.

- m) the safety equipment is delivered for a duration of 2 hours. By purchasing your bracelet, you expressly acknowledge that you have read these regulations and accept it in its entirety.
- n) each user progresses along the routes independently and under their own responsibility

4. IMPORTANT:

in order to allow you to spend a pleasant moment, we remind you that moving from one tree to another, several meters above the ground - totally autonomous and self-insured and under your own responsibility - constitutes an activity at risk that implies respect for all of the present regulation.
